- (3) A 40-unit low-income multifamily rental housing development consisting of twenty buildings located north of 608 Cary Road on the west side of the County Highway D right-of-way, City of Hurley, Iron County, Wisconsin, owned and operated by Impact Hurley Homes, LLC, the initial owner, principal user or beneficiary, including any affiliate thereof and any of its successors or assigns; maximum amount of loan: \$11,350,000.
